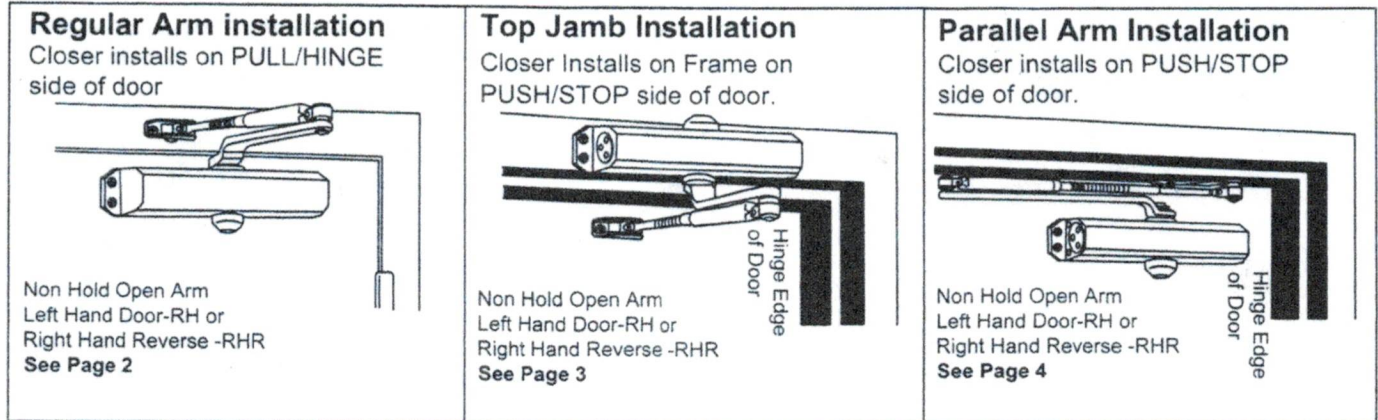

DOOR CLOSER ADJUSTMENT

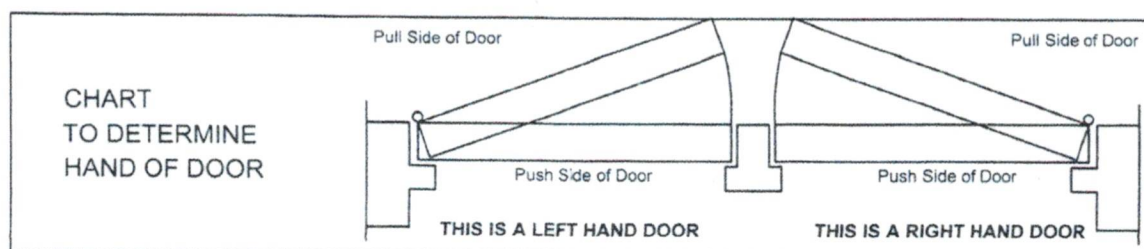
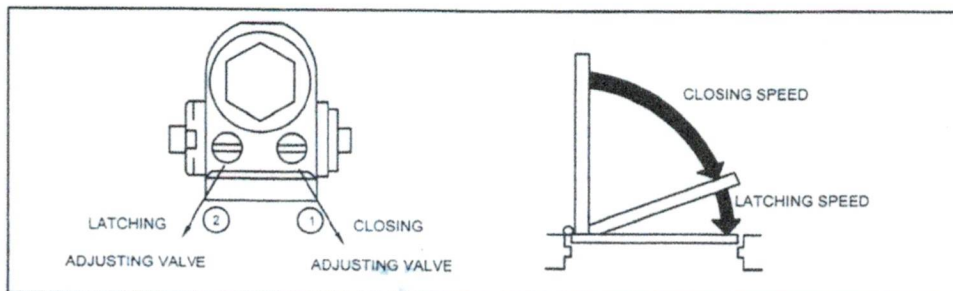
CLOSING CYCLE

NOTE: CLOSING arcs (CLOSE and LATCH) are controlled two (2) separate speed adjusting valves. adjust the CLOSING speed first, then adjust the LATCHING speed.

- CLOSING speed adjustment is accomplished by full rotations of the speed adjusting valve.
 - Turn the speed adjustment valve CLOCKWISE for a SLOWER CLOSE arc closing speed.
 - Turn the speed adjustment valve COUNTER-CLOCKWISE for a FASTER CLOSER arc closing speed.
- LATCH speed adjustments is accomplished by full rotations of the speed adjusting valve.
 - Turn the speed adjustment screw CLOCKWISE for a SLOWER LATCH arc closing speed.
 - Turn the speed adjustment screw COUNTER-CLOCKWISE for a FASTER LATCH arc closing speed.

CAUTIONS!

Do not turn speed adjusting valve more than two (2) full turns counter-clockwise from its factory set position, as two speed adjusting valves could become dislodged from the door closer body, resulting in the loss of internal fluid and failure of the device.

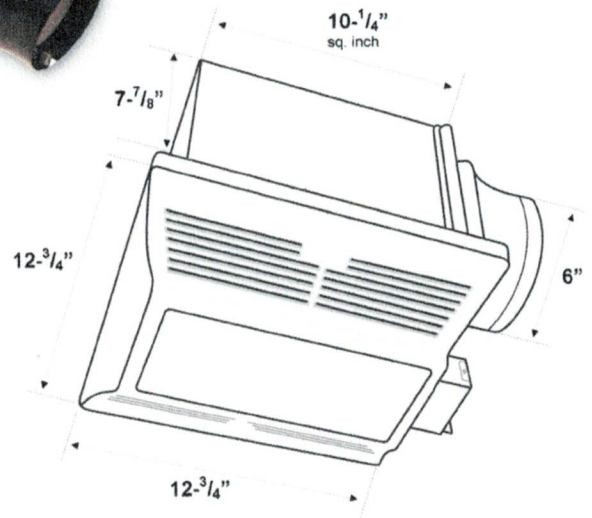
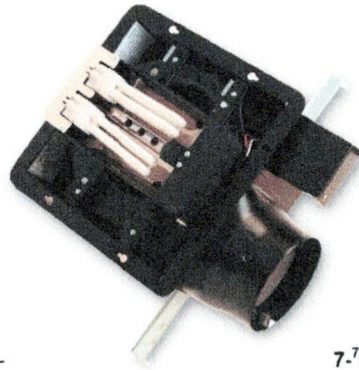

PGT® Windows & Doors

Warranty

PGT Industries, Inc. ("PGT"), warrants to the original owner that any PGT manufactured window or door shall be free of material defects in manufacturing and/or materials for the period specified below. This warranty applies to the window/door under normal use and service, subject to the conditions and limitations herein listed, and for only so long as the original owner owns the windows and doors. PGT's liability under this warranty shall be limited to the repair or replacement of nonconforming goods or parts, at PGT's option. PGT shall not be responsible for any incidental or consequential damages that may arise out of a claim for breach of this warranty.

This warranty covers only those manufacturing and material defects as specified herein and does not include defects or damages attributable to improper installation and/or application of product, use or maintenance; normal weathering; highly corrosive environments; defects caused by accident, fire, flood, acts of God, vandalism, riot or civil disorder; building settlement or structural failures of walls or foundations; stresses resulting from localized heat which causes excessive temperature differentials over glass surface edges, or occurrences beyond PGT's control.

This warranty shall be null and void if harmful solvents are used to clean the frame and/or sash members, or if the frame and/or sash members are painted or coated in anyway; or if any other "aftermarket" products are applied to the PGT product such as window films.

PGT's sole responsibility under this warranty is limited to repairing or replacing (color may vary due to age, weathering or die lot differences), free of charge or at a prorated price per guidelines of this instrument, any part or parts of the windows that do not comply with the terms of this warranty. The original warranty period shall not be extended by such repair or replacement.

PGT reserves the right to discontinue or change the design and specification of any product it manufactures. Should the component of the window/door originally installed not be available, PGT shall have the right to substitute such part determined by PGT to be of equal quality and performance.

Aluminum Frame

The aluminum components of the frame/sash members are warranted to be free of defects in materials and workmanship for a period of three (3) years after the date of delivery by PGT. Warranty is null and void if any aluminum component has direct contact with a copper treated wood, such as Alkaline Copper Quaternary (ACQ).

Vinyl Frame

The vinyl components of the frame/sash members are warranted against defects resulting from blistering, chipping, cracking, peeling, corroding or pitting for a period of ten (10) years after the date of delivery by PGT. Should the vinyl fail after year 10 as a result of defects described above, PGT will charge the purchaser, and the purchaser shall pay PGT a fixed price for the replacement frame/sash at that time, according to the formula below.

Years 11 through 15	- 50% of the then-current price for the frame/sash
Years 16 through 20	- 70% of the then-current price for the frame/sash
Years 21 through 25	- 80% of the then-current price for the frame/sash
Years 26 on	- 90% of the then-current price for the frame/sash

Glass

Glass has prevalent characteristics such as bubbles, slight discolorations, blurs, and hairline scratches. These are expected, as they are inherent qualities that meet or exceed federal specifications DD-G-451D. Heat strengthened or tempered glass may have slight distortions as an inherent quality. Glass with special coatings may require special cleaning, please see your PGT dealer.

PGT warrants against stress cracks in glass panels for a period of 12 months after the date of delivery by PGT. Stress cracks in glass panels can result from natural settlement or extreme thermal changes between inside and outside temperatures. Stress cracks are not the result of defects in materials and/or workmanship. In the event of a stress crack during the 12-month warranty period, PGT will ship a replacement panel to the original owner at no cost (installation costs are not covered).

Insulating Glass Unit

The sealed glass component is warranted to be free of defects resulting in material obstruction of vision or film formation caused by dust or moisture in the dead air space of a sealed unit for a period of ten (10) years after the date of delivery by PGT. Should the glass fail after year ten as a result of defects described above, PGT will charge original owner, and the original owner shall pay PGT, a fixed price for glass at that time, according to the formula below. In the event of glass failure, PGT will ship a replacement panel to the original homeowner at no cost (installation costs are not covered).

Years 11 through 15	- 50% of the then-current price for the glass
Years 16 through 20	- 70% of the then-current price for the glass
Years 21 through 25	- 80% of the then-current price for the glass
Years 26 on	- 90% of the then-current price for the glass

Laminated Glass Unit

The glass is warranted to be free of defects resulting in material obstruction of vision or delamination for a period of five (5) years from the date of delivery by PGT.

Screen and Moving Parts

The screen and moving parts shall be warranted for a period of three (3) years after the date of delivery by PGT to be free from material defects in manufacturing and/or materials.

Claims

Any claim for defect under this warranty must be submitted promptly after discovery to the dealer from whom the product was purchased and within the warranty period specified above. If you cannot locate your PGT dealer, you may contact PGT for assistance.

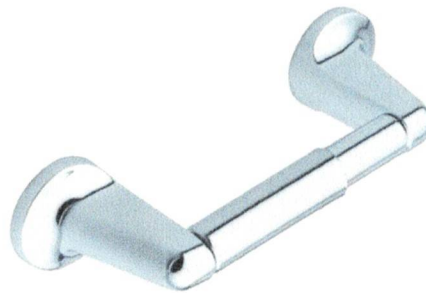

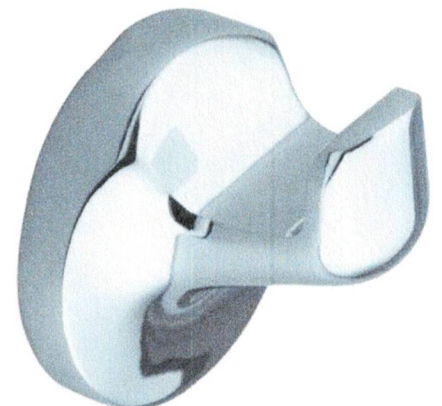
