I/We further understand and agree that, in order to use a different email address or opt out for casting votes electronically, I/ we must notify the Association in writing of the change of email address/status no later than fifteen (15) days prior to the meeting or election in which the Unit Owner wishes to vote by electronic means. If I/we do not provide timely written notice of this change of email address to the Association as provided herein, I/we further understand and agree that I/we may not be able to vote electronically until the next membership meeting and/ or election.

However, this means you will still receive mailed notices from the Association (except for electronic voting links).*
